Re: PVC Tapes. Product Change Notification

DEHP (DOP) Replacement

Date 10 July 2014

Dear Valued Customer,

As outlined by the EU regulation on Registration, Evaluation and Authorization of Chemicals (REACH), Nitto is committed to comply with this REACH regulation and therefore implement changes within our PVC/Tape product lines to meet the latest regulatory requirements.

1. Nitto Europe uses actually DEHP (DOP) as plasticizer in the PVC tapes and this particular plasticizer is listed as SVHC substance in REACH, so Nitto Europe is improving and resolving this by replacing the actual plasticizer by DINP

a. DEHP Di(2-ethylhexyl)phthalateb. DINP Diisononyl phthalate

2. PVC/T items concerned:

- 3. Schedule
 - a. Availability of IEC approvals with classifications for the electrical insulating tapes: 30 September 2014
 - b. Start of mass production: 15 December 2014
 - c. Transition period: 15 December 2014– 15 April 2015. During these months Nitto will use up the DEHP finished stocks first and build up DINP stocks. It is unavoidable, seen the wide variety of tape types-dimensions-colors-packaging standards, that Nitto supplies during that period PVC tape cartons with DEHP as well as DINP plasticizer. Per carton there will be only DEHP rolls or DINP rolls, not mixed.
- 4. Property differences. The properties will not change.
- 5. Certifications and application temperature ranges: no change:

- 6. Label identifications
 - a. Individual roll and 10-roll packs: no change
 - b. Core prints: no change.
 - c. Carton label prints: during the first 4 months after the replacement (15 December 2014 till 15 April 2015) Nitto will stamp the new manufactured PVC/T version by a "N" beside the carton label
- 7. Prices, warranty, warranty period: no change
- 8. Availability of samples. On your request to your usual local Nitto contact we can supply already now one or a few sample rolls of the new developed PVC tapes with DINP plasticizer. These rolls are available as sample in the standard sizes 19 and 25mm wide by 10m long and the following colors only:
