1. Definitions

“**Sonepar**” means Sonepar SAS, a French *société par actions simplifiée*, having its registered office at 25 rue d’Astorg, 75008 Paris, France, and registered with the registry of commerce in Paris under the number B 585 580 202.

“**Green Index**” means the environmental profile of a product consisting in a score, based, only and solely, on an evaluation of CO₂ emissions attached to such product as verified, assessed and/or certified by independent certification bodies or third parties under PEP Ecopassport or other relevant and reputable environmental declarations, norms, or standards .

“**Supplier**” means the company manufacturing and/or selling the products to Sonepar.
